1. To Receive apologies for absence

1.1 Apologies were accepted from Borough Councillor Mrs V Spikings & County Councillor Mr C Dawson.

2. To receive any declarations of Interest in items on the agenda

2.1 Cllr Esse declared an interest in agenda item 9.1b (planning application 21/00942/LB)

3. To approve and sign the minutes of the meeting held 20th July 2021

3.1 The minutes of the meeting were approved without amendment and signed by the Chairman as a correct record.

4. Clerk's report (for information only)

- 4.1 No further updates on the additional Dog Waste at this time, still awaiting the outcome of the licence application.
- 4.2 The setting up of a parish council Facebook page has been put on hold until after the Clerk has attended training on the subject later in the month.
- 4.3 The Clerk will be attending Neighbourhood Planning and GDPR training next month.
- 4.4 One Allotment Tenant has given notice to surrender his tenancy effective September 2022; the vacant plot will be reallocated as per the Allotment Policy.
- 4.5 All other matters that the Clerk has been working on are reported in the minutes.

- 7.1 Whilst there were no updates on previously reported issues, it was noted that white lines had again appeared around many of the existing issues, including those where the rain had washed away previous markings, but work was still waiting to be being carried out.
- 7.2 No new issues were identified but the Clerk will report outstanding issues again.
- 7.3 Confirmation had been received that the application for CIL Funding to extend the footpath in Barroway Drove was successful. The Council **RESOLVED** to accept the grant and asked the Clerk to make contact with the relevant parties so that would can begin as soon as possible.
